# EMISSION REDUCTIONS

#### **EMISSIONS REDUCTION TARGETS**

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

# Staff work 100% remotely

The Business have made a strategic decision that all current and future staff will work 100% remotely and there will be no office location.

# Paperless

The Business operates fully digitally - this means that all our documents are stored via a Cloud Service and anything sent to clients is digital only and we actively encourage clients to view these digitally (i.e. when CVs are sent we encourage these not to be printed off).

Anything that needs a signature is done digitally and we do not require wet signatures on our documentation.

• Public Transport for Travel (work purposes)
Travelling for work purposes is extremely
minimal at Osborne Thomas and our client
base has adopted a hybrid working model so all
meetings are now taken online. If travel is ever
needed then staff will be encouraged to take

Public Transport, of which the company will

expense.

We project that carbon emissions will decrease over the next five years to 5,050.40 tCO2e by 2027. This is a reduction of 20%.

# FUTURE PLANS

### IN THE FUTURE WE HOPE TO IMPLEMENT FURTHER MEASURES SUCH AS:

# Supply Chain Carbon Reviews

Currently Osborne Thomas utilise suppliers to assist with the running of the business. We will review each supplier against an internal scoring process in terms of how sustainable they are and their pledge to achieving Net Zero 2050.

# · Digital Cleansing

Osborne Thomas are a paperless office and everything is stored digitally. We will be working with our ICT supplier to ensure that we implement a Data Cleansing (as part of our Waste Management Policy) and our operations staff will be tasked with a yearly archiving of our SharePoint files.

# Waste Management Policy

Currently our ICT supplier will dispose of any electrical waste however Osborne Thomas will be writing and implementing their own Waste Management Policy in regard to this and other Waste Management issues. Any supplier that Osborne Thomas engages with moving forward will be aware of our policy and must adhere to it.

### · Carbon Certification

Osborne Thomas will research and, if financially agreeable to the business, will implement a certification into the business.

# Green Energy Tariffs

Osborne Thomas employees (current and future) will work 100% remotely and we will encourage all staff to take the Green Energy options when looking at their tariffs for both electricity and gas. Although we are unable to force this, we will actively engage in conversations with employees around achieving Net Zero and this topic will be covered.

# Internal Training

We will deliver internal training and focus group sessions around reducing Carbon Footprint at home, including half yearly refreshers. We will input this training as part of on-boarding for new staff by the start of 2023.

### · Plant A Tree Scheme

Osborne Thomas will research into schemes for planting trees - due to us having no office location this will need to be done externally. However, this scheme must be financially agreeable to do the business.
